CEO Course Description

Creating Entrepreneurial Opportunities (CEO) Description:

CEO is a year-long course designed to utilize partnerships that provide an overview of business development and processes. Our local business community partners with area schools to create project-based experiences for students by providing funding, expertise, meeting space, business tours and one-on-one mentoring. Students visit area businesses, learn from guest speakers, participate in a class business, write business plans, and start and operate their own businesses. Business concepts learned through the experiential CEO class are critical; the 21st skills of problemsolving, teamwork, self-motivation, responsibility, higher-order thinking, communication and inquiry are at the heart of a student's development throughout the course.



Learning Outcomes

At the end of the CEO course, students are expected to be able to:

- 1) Create and Present an effective business plan
- 2) **Demonstrate**-effective communication and collaboration skills
- 3) **Demonstrate** their understanding of appropriate professional attire
- 4) Compare and Contrast a wide variety of businesses
- 5) Interact with business owners, community leaders, and class guests
- 6) **Execute** the creation of a small business

How will we know that we've achieved these outcomes?

- 1) Students will formulate, research, write, and present three business plans
- 2) Students will
 - write weekly journals
 - interact each week with local business and community leaders
 - observe local businesses in operation
 - actively participate in a class business
 - schedule, plan, and work together at various local events
 - communicate and interact with their business mentor
 - start their own business
 - present their business at the CEO trade show
- 3) Students will attend class each day dressed in appropriate professional attire
- 4) Students will visit 30-50 area businesses
- 5) Students will regularly interact and communicate with:
 - business owners
 - guest speakers
 - guests who visit the class
 - business mentors in a lunch or dinner setting
- 6) Each student will start their own small business and present it to the community at the CEO Trade Show



Investing in the Program: What's the Money Used For?

Congratulations! You have the agreement signed and are ready to begin a CEO class in your community! However, you need to generate more investors to support the program and they want to know how their investment is going to be used. The information below should help you answer those questions!

The Teacher (20-40 investors)

The teacher is a half time position and the school district will be reimbursed for half the teacher's salary. The number of investors you need to support this position is dependent upon how much you decide to pay the teacher.

Program Expenses (5 investors)

- Annual report
- Trade show advertising
- Social gatherings (for students and investors)
- Student recruitment (materials, social gathering)
- Teacher travel to Effingham for training

The Second Year (3 investors)

Annual renewal fee to Institute (for training, materials, mentoring, content)

- select students through a rigorous application process
- serve students from public and private high schools
- meet for 90 minutes each day
- provide 2 high school credits
- utilize area businesses as classrooms
- visit dozens of area businesses each year
- host 50-60 guest speakers each year
- emphasize 21st century Learning skills
- provide the opportunity for each student to start their own business
- provide a mentor from the business community for each CEO student
- host an annual trade show to showcase student businesses

Entrepreneurship Education

seeks to prepare people, especially youth, to be responsible, enterprising individuals who become entrepreneurs or entrepreneurial thinkers and contribute to economic development and sustainable communities. The CEO program is much more than a textbook course. Rather, students are immersed in real life learning experiences with the opportunity to take risks, manage the results, and learn from the outcomes

Entrepreneurship education is not just about teaching someone to run a business. It is also about encouraging creative thinking and promoting a strong sense of self-worth and accountability. Through entrepreneurship education, students learn how to create a business, and much more.

The CEO class covers the basics of conceptualizing, starting and running a small business. Concepts such as supply and demand, cost/benefit analysis, competitive advantage, and opportunity recognition are covered. In addition, coursework includes: innovative thinking strategies, product development, business structure, marketing, financial strategies, record keeping, and preparing an income statement, balance sheet, income and cash flow statements.

Entrepreneurial thinking (outside-the-box problem solving) is utilized throughout the course. The course is built around the National Entrepreneurship Standards and is linked to the Illinois Learning Standards.

- The CEO class meets Monday through Friday, 7:30 AM-9:00AM and is a year-long
- . The class meets in local businesses and changes location every nine weeks.
- · In addition to providing a professional business setting for the class, the various locations help students from multiple school districts establish a common identity based on their CEO experience.
- · The class is offered to high school juniors and seniors throughout Crawford County.
- · A key part of the success enjoyed by the class is rooted in a teacher who challenges each individual student and can manage constant change in the classroom. In addition, encouraging the active participation of business and community leaders adds to the cultivation of learning opportunities, mentoring, and networking.
- · Support from school administrators throughout the county is essential to the development and ongoing success of the class. That support is evident in the cooperation and scheduling of students from multiple school districts
- · Funding comes from Business Partners and student projects.
- * The student selection process is a defined process beginning with the school recommendation. In addition to a written request for admission, a student applicant must submit letters of recommendation and complete an entrepreneurial profile. Grades are not the defining admission standard.
- It is a year long high school course
